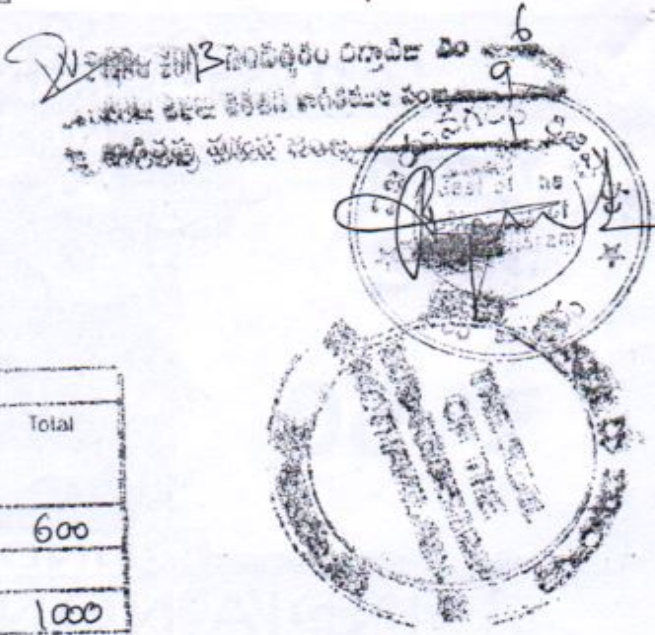
Now this deed witnessed: -

The above members will be the core trustees of the trust and shall preside over the meetings of the trust. The managing trustee can opt any other persons as a trustee by selection and can be appointed as the member of the trust board for such period and may be specified by the first trustees.


There shall not be at any time more than 5 trustees, One of the trustee shall always be from the family of the settler and the Managing Trustee shall always be from such family members, unless there is no such family member who is physically and mentally fit or being fit declines to be a trustee.

The board of trustees hereby authorized and empowered to nominate any other persons as trustee as long as trustees do not exceed 5 in member.

WORKING:

The trustees shall have power to accept donations either in cash or in kind, movable or immovable properties either with or without any special condition attached to it provided it do not contravenes clause 3 here in above.

- 5) It shall be competent for the trustee from the time to time, make and enforce all such rules, regulations and /or bye law not in consistent with the express provisions of this trust as the trustees may deem proper for securing the facilitating the administration and management in detailed affairs of the trust, and for convening, conducting, and regulating the meeting of the trustees and for appointing sub-committees and generally for the management and administration of the trust estate and also open time to time repeal, alter, amend, rescind or add to all such rules, resolution and bye-laws and also to pass resolution in connection with all or any of the said matters of their meeting.
- 6) The trustees shall have power from time to time to increase or decrease the corpus of fixed property of the trust and this corpus will not be used in contravention of clause 3 here in above.
- 7) The managing trustee/ chairman have to conduct meetings to approve and maintain the working of the trust. In case, the managing trustee/ chairman shall not perform the duties of the managing trustee/ chairman, the Secretary shall perform the duties of the managing trustee/ chairman.
- 8) The trustees shall also have power to invest/mortgage the trust money in any government securities or in any other securities approved under the Indian trust act and also to invest in such manner as may be directed by the Board of Trustees, and from time to time vary the investments in which the Trust funds may be invested.
- 9) The Trust moneys shall not be invested with any private individual or firm or association of persons or body of individuals.
- 10) The Trust may open saving or any other type of bank accounts with the schedule banks only. The Chairman/Secretary will operate the same as per resolutions made in ~~Governing body as well as general body meetings.~~

- 11) The trustees shall have power and authority to appoint or engage and at their discretion remove, dismiss to suspend due or more secretaries, treasures, supervisors, cashiers, accountants, clerks, chowkidars, attendants, servants and other officials or employees and persons in permanent, temporary of special service in connection with work of the trust, trust estate, trust funds, and trust properties as they may from time to time think fit and to determine their powers, and duties and fixed their salaries bonus or emoluments and to require security in such instance, amount as the trustees may think fit. The trustees shall also have power to found and maintain provident funds, gratuity funds, personal and other funds for any employees and make rules and regulations regarding the same.
- 12) The Secretary shall act as chief functionary of the trust. She/he shall keep all accounts regularly and properly maintained. She/he shall perform all the duties as entrusted by the managing trustee as well as board of trustees. She/he shall be responsible for the safe guard of the properties of the trust. She/he should prepare the annual report and submit the same to the general body.
- 13) The trustees shall be entitled to reimburse out of the trust estate, all expenses incurred in or about the execution of the trust or powers here in or in carrying out the trust its object and affairs of or the properties. The trustees shall be entitle to be indemnified by the trust properties, against the consequences of all lawful acts done by the trustees in the course of and discharge of their duties as the trustees of these trust and all costs, charges and expenses thereof.
- 14) For the purpose of carrying out of the objects of the trust, the trustees have power to acquire by purchase or on lease or on mortgage or otherwise any immovable properties of any tenure and in case of vacant land the trustees and to do all acts necessary and incidental there to.

ACCOUNTS:


The account books of the trust shall be closed on 31st March of every year and proper book of account shall be audited by a C.A. (Chartered Accountant) every year..

- 15) It is mutually considered that the objects of the trust will be better achieved if the income of the trust is exempt under the Income Tax Act, In case, however a particular clauses or clauses will have restricted meanings so that the relevant income tax provisions will always have for overriding effect.
- 16) In the event of dissolution of the trust, there remains, after the satisfaction of all debts and liabilities any property what so ever the same shall be not paid to or distributed among the member of the trust and shall be given to any other institution with similar objects and aims which has been recognized by the income tax act, 1961 or other such provision as determined by the members of the majority of the trustees on or before the time to dissolution.
- 17) That no alteration, amendment or addition to the terms of this provision could be made without the previous approval of commissioner of the Income Tax, having jurisdiction over the trust.






